Summary Information for RR20-0089, a contract with Clear Selections Group, Inc., doing business as Liberty Waste Management

This contract is used for on-call rental services of portable toilets, citywide. One key component of this contract is the provision of restroom trailer service, including those used for DOTI's mobile Public Restroom Project. The contract also includes the maintenance and cleaning of units, use at special events and emergency uses, including use to support overnight shelters in the event of a plumbing emergency. Plumbing maintenance can be challenging in these settings, and portable trailers and portolets provide critical services when building plumbing is down for repairs

Additional Background on Mobile Restroom Project

The mobile public restroom project began in March 2016 with two trailer-based restrooms. One unit was placed on the 16th Street Mall, and the other was placed on Clarkson Street just off East Colfax. Each trailer houses three restrooms, including one ADA-accessible unit. Each restroom has a toilet, hand soap and a sink with running water. The trailers are monitored during operational hours by an on-site attendant. The trailers have been in continuous operation since March 16, but have moved locations every three to six months. Currently, the trailers are located at Market and 21st, and 21st and Stout. Current hours of operation are 6am to 10pm with extended hours on weekends.

Additional Wastewater funding has been allocated for 2020 for a permanent restroom in Sonny Lawson Park and a third mobile unit. There is also a desire to move the Ballpark (Market and 21st) unit to 24-hour operation.
