AMENDATORY AGREEMENT

This **AMENDATORY AGREEMENT** is made between the **CITY AND COUNTY OF DENVER**, a municipal corporation of the State of Colorado (the "City") and **ConvergeOne**, **Inc.**, a Minnesota corporation whose address is 10900 Nesbitt Ave S, Bloomington, MN 55437, 82601 (the "Contractor"), jointly ("the Parties").

RECITALS:

A. The City and ISC, Inc. ("ISC") entered into Agreement dated October 24, 2018 (the "Agreement"), to provide the City with a replacement emergency 911 phone system.

B. Contractor acquired VT Consolidated, Inc. and its affiliates on January 8, 2019, including ISC and Venture Technologies, Inc. ("Venture Technologies").

C. In connection with Contractor's affiliate integration activities, effective December 31, 2019 Contractor merged ISC into Venture Technologies, with Venture Technologies being the surviving entity.

D. The Parties now wish to assign the Agreement from Venture Technologies (which assumed the Agreement as a result of the merger with ISC, Inc.) to Contractor.

NOW THEREFORE, in consideration of the premises and the Parties' mutual covenants and obligations, the Parties agree as follows:

1. Contractor shall perform the obligations of Venture Technologies that are enumerated under the Agreement, and Contractor agrees to be bound by all the terms of the Agreement in every way as if an original party to such agreement.

2. The City releases Venture Technologies from all claims for any liability that has arisen or may have arisen in respect to the Agreement. The City accepts the liability of Contractor in lieu of the liability of Venture Technologies. The City and Contractor shall be bound by the terms of the Agreement in every way as if the City and Contractor were the original parties to the Agreement.

3. This Amendatory Agreement supersedes the Agreement entered into by Venture Technologies and the City, and all the rights and obligations of Venture Technologies under the Agreement are completely extinguished.

4. All references in the Agreement to ISC and/or Venture Technologies are hereby changed to ConvergeOne, Inc.

5. As herein amended, the Agreement is affirmed and ratified in each and every particular.

6. This Amendatory Agreement will not be effective or binding on the City until it has been fully executed by all required signatories of the City and County of Denver, and if required by Charter, approved by the City Council.
