16	WHEREAS, the projected cash balance of the Risk Management Fund in 2020 will not be			
17	sufficient to fund the \$1.4 million in replacement police vehicles and cover the average cost of			
18	annual property damage; and			
19	WHEREAS, when the revenue from insurance reimbursements and subrogation claims are			
20	not enough to cover the obligations of the Special Revenue Fund, the General Fund must cover			
21	the variance;
