#### FIRST AMENDMENT TO AGREEMENT

THIS FIRST AMENDMENT TO AGREEMENT is made and entered into on the date of the City's signature page by and between the CITY AND COUNTY OF DENVER, a municipal corporation of the State of Colorado ("City"), and INLAND TECHNOLOGIES INTERNATIONAL LIMITED (ITI), a Minnesota corporation authorized to do business in Colorado (the "Operator").

#### WITNESSETH:

WHEREAS, the parties entered into an Agreement dated February 14, 2014, for aircraft deicing fluid storage, distribution, and recycling services for Denver International Airport ("Existing Agreement"); and

WHEREAS, the parties desire to amend the Existing Agreement as hereinafter set forth;

**NOW, THEREFORE,** for and in consideration of the premises and other good and valuable consideration, the parties hereto agree as follows:

- Section 6.A of the Existing Agreement, entitled "6. MAXIMUM CONTRACT AMOUNT, FUNDING," is hereby amended by deleting "Four Million Three Hundred Seventy-Five Thousand Dollars (\$4,375,000.00)" as the Maximum Contract Amount and stating a new Maximum Contract Amount of "Five Million One Hundred Seventy Five Thousand Dollars (\$5,175,000.00)".
- 2. Except as otherwise provided in this First Amendment, all of the terms, provisions, and conditions of the Existing Agreement shall remain in full force and effect as if fully set forth herein and are hereby ratified and reaffirmed.
- 3. This First Amendment is expressly subject to and shall not be or become effective or binding on the City until approved by City Council and fully executed by all signatories of the City and County of Denver. This First Amendment may be signed electronically by the Parties in the manner specified by the City.
