WHEREAS, the occurrence or imminent threat of widespread or severe damage, injury or loss of life or property resulting from COVID-19 requires emergency action and resources to avert danger or damage and to protect public health; and,

WHEREAS, the home rule Charter of the City and County of Denver and the Colorado Disaster Emergency Act, Colo.Rev.Stat. §24-33.5-701, et seq., grant authority to the principal executive officer, Mayor Michael B. Hancock, to declare a local disaster; and,

WHEREAS, on March 12, 2020, Mayor Hancock filed with the CCD Clerk and Recorder, a State of Local Disaster Emergency Declaration (hereinafter "Declaration") (copy attached), which is effective until May 11, 2020, unless extended or rescinded by the Denver City Council (hereinafter "Period of Emergency"); and,

WHEREAS, Denver City Council has broad general police powers to preserve and enforce good government, general welfare, order and security of the City and County and the inhabitants thereof under Section 3.2.3 of the Charter; and,

WHEREAS, the Department of Public Health and Environment has broad powers to control communicable diseases under Section 2.12.2 of the Charter and all other powers granted by state law, Colo.Rev.Stat. §24-33.5-709; and,

WHEREAS, on March 23, 2020, Denver City Council adopted an ordinance to allow emergency cancelations of the regular Monday schedule and take other actions to supersede City Council rules; and,

WHEREAS, Denver City Council and other public bodies that are unable to cancel or suspend meetings are looking for innovative and inclusive ways to continue to provide the public the fullest possible access to the deliberations and proceedings of public bodies; and,

WHEREAS, state and local public health shelter and social distancing orders have been issued and will be issued; and,

1	WHEREAS, the Denver City Council and Mayor Michael B. Hancock hereby exercise a		
2	powers granted to the legislative and executive branches to continue to provide essentia		
3	government services and offer innovative and inclusive technological solutions so that the public
