5 **Laying out, opening and establishing as part of the City street system parcels of**  
6 **land as a public alley bounded by West 4th Avenue, North Santa Fe Drive, West**  
7 **5th Avenue and North Inca Street; and, North Santa Fe Drive located between**  
8 **West 4<sup>th</sup> Avenue and West 5<sup>th</sup> Avenue.**

9 **WHEREAS**, the Executive Director of Public Works of the City and County of Denver has  
10 found and determined that the public use, convenience and necessity require the laying out, opening  
11 and establishing as a public street and as an alley designated as part of the system of thoroughfares  
12 of the municipality those portions of real property hereinafter more particularly described, and,  
13 subject to approval by resolution has laid out, opened and established the same as a public street  
14 and as a public alley;

15 **BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

16 **Section 1.** That the action of the Executive Director of the Department of Transportation  
17 and Infrastructure in laying out, opening and establishing as part of the system of thoroughfares of  
18 the municipality the following described portions of real property situate, lying and being in the City  
19 and County of Denver, State of Colorado, to wit:
