0	WHEREAS, pursuant to the provisions of Section 12-61 of the Denver Revised Municipal		
1	Code ("D.R.M.C."), and by Ordinance No. 302, Series of 2019, there has been approved a		
2	Comprehensive Plan 2040 for the City and County of Denver; effectively replacing and superseding		
3	Comprehensive Plan 2000; and		
4	WHEREAS, pursuant to the provisions of Section 12-61 D.R.M.C., and by Ordinance No. 303,		
5	Series of 2019, the City accepted Blueprint Denver: A Blueprint for an Inclusive City ("Blueprint		
6	Denver (2019)") as an amendment to supplement Comprehensive Plan 2040; and		
7	WHEREAS, the City wishes to repeal and replace The Future Places 2019 Plan Map of		
8	Blueprint Denver (2019), found at pages 142 and 143 with a updated Future Places 2020 Plan Map		
9	to reflect the change in the Overland Park Neighborhood in Council District 7; and		
20	WHEREAS, members of the City Council, duly authorized by the president of council have		
21	monitored the process whereby said Future Places 2020 Plan Map has been formulated;		
22	WHEREAS, said Section 12-61 of the D.R.M.C. provides for the amendment of the		
23	Comprehensive Plan 2040; and		
24	WHEREAS, the Future Places 2020 Plan Map has been approved by the Denver Planning		
25	Board and transmitted by the manager of Community Planning and Development to the Mayor and		
26	City Council;		
27	NOW THEREFORE,		
28	BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:		
29	Section 1. The Future Places 2020 Plan Map is hereby accepted and adopted as part of		
80	Blueprint Denver (2019), a supplement to Comprehensive Plan 2040, pursuant to Section 12-61,		
31	D.R.M.C., and hereby amends Blueprint Denver (2019), to incorporate the Future Places 2020 Plan		
32	Map and corresponding plan maps; and said Blueprint Denver (2019), as amended was filed with		
33	the City Clerk, Ex-Officio Clerk of the City and County of Denver, on the 18th day of March, 2020,		
34	as City Clerk Filing No. 20190013B.		

Section 2. That said Future Places 2020 Plan Map and corresponding plan maps replace

and supersede the Future Places 2019 Plan Map and corresponding plan maps at pages 142-143, 282-283, and 288-289 of Blueprint Denver (2019) for the City and County of Denver.

Section 3. That this adoption and acceptance of the Future Places 2020 Plan Map, as it amends Blueprint Denver (2019), and of any subsequent amendment thereto, in conjunction with Comprehensive Plan 2040, is intended to establish the official guide for officials of the City and County of Denver and private citizens when making decisions affecting the future of land use and transportation in and for the City and County of Denver, as defined in said plan; provided however, that such approval shall not preempt the decision making powers vested by law or administrative directive in the Mayor, the Council or any other official of the City and County of Denver with respect to, but not limited to: a zoning map amendment, a zoning language amendment, a dedication or vacation of a street, alley or other public way, a designation of a park, the issuance of a revocable permit, a conveyance or acquisition of real property by the City and County of Denver, or an appropriation for or construction of a capital improvement; and provided, further that it is expressly understood that judgment must be exercised in the application of Blueprint Denver (2019) in the decision making processes of the Mayor, Council and other officials of the City and County of Denver.
