GovDeals will provide access to an online auction software platform and a customer base for use by the City to auction various surplus property; to include such items as heavy equipment, vehicles, tools, office equipment, etc. The vendor will collect all payments and applicable sales taxes and remit net proceeds to the City. Buyers will pay a sales premium directly to GovDeals. The City will receive no billing for this service. Estimated revenue to the City under the extended term is \$12.5 million. Under the current agreement, the City has received \$11,157,140 in revenue.
