5. General description or background of proposed request. Attach executive summary if more space needed:

Questica is the City's budget system. It was first implemented in 2015 as a Software as a Service (SaaS - cloud-based service) solution, and we are at the end of the first five-year contract term for subscription services. It was first procured through a formal bid process through the City's Purchasing division. The prior budget system had been in place for 16 years and was no longer supported by the vendor. This contract request extends the subscription service for another 5 years. While the Questica Budget system is used primarily by the Budget and Management Office, all City agencies utilize the system to develop their annual budget requests (with the exception of DEN). There are approximately 200 users across the City. Questica's performance module will be added under the new contract as per their new fee structure and will be implemented with the next upgrade.

#### Term exceeding more than 3 - 5 years per Executive Order 8.

Per Executive Order 8: "Agencies should limit the duration of contracts to three to five years at which time a new solicitation should be initiated absent special circumstances." For most software applications, they cannot be simply unplugged and replaced with a new application; therefore, there will be several special circumstances that would provide for a justification to deviate from this policy. For this request, the information below provides examples of special circumstances directly related to the Questica Software contract amendment request.

The special circumstances that justify a contract term that exceeds three to five years are listed below:

- Situations where standardization of equipment or continuity of service is required;
- Situations where competition does not exist;
- Situations where economic factors make it unfavorable for the City to re-bid a contract.

The Questica Budget Management software application has been customized for the City, it integrates with the City's Enterprise Resource Planning system, Workday, both on the Human Resources and Financials modules and has been configured so it is in alignment with the City's specific organizational and financial structure. All City Agencies (excluding DEN) use the software and approximately 200 individual users have been trained and are efficient with this application so the continual use of this application will allow the Budget Management Office to provide continuity in its internal business functions as well external services with all City agencies. The software is used by the Budget Management Office, on behalf of the Mayor's Office, to meet charter requirements by producing the annual budget.

### Competition does not exist:

As the City already has purchased, implemented, has been trained on and intends on using the Questica Budget Management software application for the foreseeable future, continual support from Questica is needed to ensure the application is functioning at is maximum performance. This is a service that can only come from Questica as they do not resell their support so an opportunity for competition does not exist.

#### Economic factors make it unfavorable for the City to re-bid a contract:

The cost to fully implement this software application was over \$1.2M. The City would incur these costs every time a new system is implemented. This is a substantial investment by the City and it would result in an unnecessary negative financial impact on the citizens of Denver if this type of system was replaced every three to five years. The City and Questica underwent a very time-consuming process which included multiple phases from the time of purchase to having a fully implemented system. These include conducting an RFP process, Technology Services review of vendor's security protocols as well as technical architecture to ensure they align with Technology Services' requirements, negotiating a Statement of Work, negotiating a contract, analysis of the City's current state, planning for the new system, designing the new system to meet the City's objectives, implementing the new system, configuring (fine tuning) the new system, testing the new system and training employees on the new system. This process took approximately a year to complete. For the City to re-bid this every three to five years would mean the opportunity for any type of return on our investment would be minimalized and the City would be in a perpetual cycle of bidding, implementing, retraining and decommissioning of previous applications.
