# **16th Street Mall Today's Challenges**

# Failing and outdated infrastructure causes frequent, disruptive maintenance

- The 38-year-old Mall costs \$1.5M+ a year to maintain
- Pavement system traps water, causing paver failure
- Slick and cracked in many places causing people to slip/fall and preventing buses from keeping traction.





# **16th Street Mall Today's Challenges**

Narrow sidewalks and frequent maintenance no longer support the number of people using the Mall today.


- Over capacity sidewalks unable to accommodate current and projected pedestrian volumes
- Frequent maintenance disrupts transit shuttle operations. Ridership will nearly double by 2035.



### **Additional Considerations**

#### Public Space/Public Life:

Continuing development of a public space and public life playbook.

#### **Business Supports:**

Developing a business support model specific to the needs of the 16th Street
 Mall business community for deployment during reconstruction.



### **Downtown Public Restrooms**

- Construct up to two\* restrooms serving all Mall users immediately adjacent to and visible from the Mall
- Site study underway for potential locations:
  - Between Welton and Tremont
  - o Champa
- Identified \$900k Wastewater funds
- Completed initial prototype study (2016)
- Delivered with separate, concurrent procurement
- DDP Initiating Design Committee




### **Environmental Assessment**

#### Project purpose and need:

- Fix deteriorating infrastructure
- Provide equitable and sufficient space for high-quality public gathering opportunities
- Improve pedestrian and vehicle safety
- Continue reliable two-way transit shuttle service on the Mall
- Honor the Mall's use and iconic design

Finding of No Significant Impact (FONSI)
Approved Nov. 2019.

# Input-Output Modeling for 16<sup>th</sup> Street Mall Project

Most common economic analysis method used at regional/state level to represent impact from investment projects.

Used to predict ripple effects as a result of a known initial change in economic activity.

Utilizing the funding programmed to date for the project—All values represent the expected impact within the 3 year period of construction.





### **Types of Economic Impacts**

#### **Direct Effect**

Result of the initial change in economic activity as well as the effects on suppliers of initially impacted industries

#### **Indirect Effect**

Subsequent supply chain effects resulting from direct impacts

#### **Induced Effect**

Effects of new earnings, investment, and government spending as a result of direct and indirect impacts




# **Funding Agreements**



# **Identified Project funding**

More than \$100 million of secured local, state and federal funds from partners including DURA, CDOT, FTA, and the Elevate Denver Bond Program, which allocated \$13 million of voterauthorized funds toward design and construction.





# **Proposed Funding Agreements**

Intergovernmental Agreement with RTD

Approves an IGA with RTD for the contribution of federal and RTD funding for the reconstruction of the 16th St Pedestrian Mall and transitway.

Interagency Agreement (IAA) with Denver Water

Approves an IAA with
Denver Water for the
reimbursement of work
completed on water lines
during the Mall
reconstruction project.

Project Funding Agreement (PFA) with DURA

Approves an amendment to the PFA with DURA to revise submittal/reimbursement dates to align with the Mall design/construction schedule and update workforce requirements to strengthen Denver's Construction Career Pilot.



### **IGA** with RTD

### **DETAILS**

IGA to accept federal transit funding and RTD local match to reconstruct the 16th Street Mall and transitway.

# FUNDING AMOUNT

City receives \$12.8 million from RTD including:

- \$11.8 million grant
- \$1 million matching funding from RTD Commits \$2.1 million city local match

#### PARTNER APPROVALS

The RTD GM signed the approved IGA in February 2020



## **IAA** with Denver Water

### DETAILS

- Agreement for reimbursement for water line work completed during project
- Replace existing 12" and 24" service lines with a single 16" main line.
- Lead pipe abatement will be performed as well.

#### FUNDING AMOUNT

City reimbursed \$5.4 million by Denver Water

#### PARTNER APPROVALS

The Denver Water Board voted on the IAA during their May 13 meeting.



### **Downtown Urban Renewal Area**

- Urban Renewal Plan originally approved by City Council in 1992
   Primary objectives:
  - Make downtown a neighborhood
  - Bring retail back to downtown
  - Provide amenities to support tourism and convention center
- City Council approved four Cooperation Agreements relating to four TIF Projects in Downtown:
  - 15-Block Property Tax and Denver Dry Sales Tax Expired 2017
  - Mercantile Square Property Tax and Sales Tax Expires 2020
  - Denver Pavilions Sales Tax Expires 2020
  - Adam's Mark (Sheraton) Sales and Lodger's Tax Expires 2020
- DURA Bonds issued to support these projects were fully repaid in 2013.



### **Downtown Urban Renewal Area**

- Amended and Restated Cooperation Agreement and Project Funding Agreement approved by City Council in 2013
- Several transformative projects for Downtown already completed:

Denver Public Schools – 1860 Lincoln Lawrence Street Community Center Union Station Parking

18th St. 2-way Conversion

Broadway & 16<sup>th</sup> Ave. Improvements

20th and Chestnut Grocery Store

Remaining Project – 16<sup>th</sup> Street Mall ~ \$56 million



### **Amend the PFA with DURA**

Revises project submittal and reimbursement dates to align with project design/construction schedule

- **DETAILS** Shifts final project submittal date to 12/31/2022 and final reimbursement date to 12/31/2027
  - Updates workforce requirements to strengthen Construction Career Pilot

No changes to the funding.

DURA Board scheduled to vote on PFA amendment at June board meeting

### **Denver Construction Careers Pilot**

To strengthen training and job placement for large public purpose projects and build Denver's workforce of the future

Prioritize disadvantaged populations and those facing barriers to employment, including people who have experienced homelessness, those exiting foster care, veterans and others.

Ensure 15% of all project construction hours are performed by apprentices in registered apprenticeship programs.

Utilize the WORKNOW platform to provide jobseekers and current workers with integrated and supportive services, trainings and resources.
