**A BILL**

**For an ordinance approving and providing for the execution of a proposed Intergovernmental Agreement between the City and County of Denver and the Regional Transportation District concerning the “48<sup>th</sup> Avenue Sidewalk Construction” program and the funding therefor.**

**WHEREAS**, the Regional Transportation District has received federal grant funds from the United States Department of Transportation and the City and County of Denver is an eligible sub-recipient; and

**WHEREAS**, the Regional Transportation District wishes to enter into an intergovernmental agreement with the City and County of Denver as a sub-recipient to use said federal dollars as partial funding for the City’s construction of six blocks of sidewalk on the south side of 48<sup>th</sup> Avenue between Brighten Boulevard and Claude Court;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** The proposed Intergovernmental Agreement between the City and County of Denver and the Regional Transportation District, for the “48<sup>th</sup> Avenue Sidewalk Construction” program, which is identified as Grant Number CO-2019-015, a copy of which is duly filed with the City Clerk, Filing No. 202054669, be and hereby is approved in all respects.

**Section 2.** The payments made by the Regional Transportation District to the City pursuant to and under the Intergovernmental Agreement shall be deposited into the Treasury of the City and credited to Special Revenue Fund No. 38000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

**Section 3.** That it be and is hereby found and determined that the budget summary of said program, to be expended by the Executive Director of Department of Transportation and Infrastructure, is as follows:

There is a City match of \$409,800. Expenditures of said funds are authorized for one year from the effective date of the construction agreement, unless an extension is authorized by the Regional Transportation District, per the terms of the agreement.

**Section 4.** The Chief Financial Officer of the City and County of Denver is hereby authorized and directed to make such book and record entries and to do such other things as may be necessary to accomplish the purposes of this Ordinance.
