This first amendment will add an additional \$1,150,000 in Urban Drainage and Flood Control District D/B/A Mile High Flood Control District (MHFD) funds, and \$1,150,000 in Wastewater Enterprise funds for the Irondale Gulch Tributaries project to design and construct drainage and flood control improvements. The improvements will be identified during design. This project is being managed through design and construction by the MHFD. These funds are in addition to \$50,000 in MHFD and \$50,000 in CCD funds previously committed through the original agreement.
