SECOND AMENDATORY AGREEMENT

THIS SECOND AMENDATORY AGREEMENT is entered into as of the date indicated on the signature page, by and between the CITY AND COUNTY OF DENVER, a Colorado municipal corporation ("City"), Party of the First Part, and BOMBARDIER TRANSPORTATION (HOLDINGS) USA INC., a Delaware corporation (the "Contractor"), Party of the Second Part;

WITNESSETH

WHEREAS, the parties entered into an Agreement dated July 27, 2018, which Agreement was subsequently amended by a First Amendment to the Agreement on June 11, 2019 (the "Existing Agreement") for the purchase of new Automated Ground Transportation System vehicles for use at Denver International Airport; and

WHEREAS, the parties desire to amend the Existing Agreement by amending an exhibit for purposes of updating the payment schedule contained therein; and

NOW, THEREFORE, for and in consideration of the premises and other good and valuable consideration, the parties hereto agree as follows:

- 1. **EXHIBITS G** is hereby amended by deleting Exhibit G in its entirety and replacing it with the attached Exhibit G.
- 2. **Section 4.01 COMPENSATION** is hereby deleted and replaced with the following-
- **"4.01 COMPENSATION** The City hereby agrees to pay the Contractor, and the Contractor agrees to accept as its sole compensation for its complete costs incurred in the project's scope of work as set forth in the Contract Documents. Payment Schedule of Values is attached as Exhibit G. Exhibit G Schedule of Values is subject to change by the City upon notice to the Contractor however any changes to Exhibit G shall be mutually negotiated by the parties."
- 3. Except as otherwise provided herein, all of the terms and conditions of the Existing Agreement shall remain in full force and effect as though set out in full herein.
- 4. This Second Amendatory Agreement shall not be effective or binding on the City until fully executed by all signatories of the City and County of Denver.
