#### PROJECT UPDATE

Recently, the Family Crisis Center was relocated to 405 S. Platte River Drive to accommodate growth needs which, in turn, allowed for utilizing the previous building for the new Solutions Center. DHHA is one of many agencies providing services at the Family Crisis Center. DHHA will occupy a portion of the first floor as their dedicated leased space and will have some areas of shared space on the first and second floor. Their dedicated space is approximately 2,906 SF. Term is for 5 years. Rent is \$10.00 per year for a total contract amount of \$50.00. This amount is the nominal lease amount determined by CAO.

The Family Crisis Center supports children under the age of 18. This is an outpatient office. This facility coordinates services of Denver Health, the Denver Department of Human Services (DHS), the Denver Police Department, the Denver District Attorney's Office, and the Denver Children's Advocacy Center to evaluate cases of alleged child abuse and neglect, and to collaborate for prevention of child maltreatment in the City and County of Denver.
