26	resilience initiatives shall be deposited into the Treasury of the City and credited to Specia		
27	Revenue Fund No. 11000, which is set forth and described in Section 20-18 of the Revise		
28	Municipal Code of the City and County of Denver.		
20	Section 3 Expenditures are hereby authorized	t for the "Climate Federal Grants" Fund	

Section 3. Expenditures are hereby authorized for the "Climate Federal Grants" Fund, Accounting No. 11010, in the amount not to exceed the amounts awarded as described in Section 2 of this Ordinance, to be expended by the Executive Director of the Office of Climate Action, Sustainability and Resiliency or his or her designate or other authorized officials. This Fund is sponsor-funded and non-lapsing.
