5 **A RESOLUTION**

6 **Approving and providing for the execution of a proposed Grant Agreement**  
7 **between the City and County of Denver and the Colorado Department of**  
8 **Public Health and Environment concerning the “Sand Creek Habitat**  
9 **Restoration” program and the funding therefor.**

11 **WHEREAS**, the City and County of Denver has given due consideration to said proposed  
12 Grant Agreement;

14 **NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY**  
15 **OF DENVER:**

17 **Section 1.** The proposed Grant Agreement between the City and County of Denver and the  
18 Colorado Department of Public Health and Environment, for the “Sand Creek Habitat Restoration”  
19 program, which is identified as Grant Number 2021\*0715, a copy of which is duly filed with the City  
20 Clerk, Filing No. 202055110, be and hereby is approved in all respects.

21 **Section 2.** The payments made by the State of Colorado to the City pursuant to and under  
22 the Grant Agreement shall be deposited into the Treasury of the City and credited to Special  
23 Revenue Fund No. 38000, which is set forth and described in Section 20-18 of the Revised Municipal  
24 Code of the City and County of Denver.

25 **Section 3.** That it be and is hereby found and determined that the budget summary of said  
26 program, to be expended by the Executive Director of the Department of Parks and Recreation, is  
27 as follows:

30 Expenditures of said funds are authorized for the period from August 3, 2020 to June 30, 2025.  
31 There is a City match of \$125,000 that is already appropriated.

3 to accomplish the purposes of this Resolution.
