This requested relinquishment is intended to facilitate development of the World Trade Center project (2016-PM- 0000745). The 50' by 16" sanitary easement abuts and extends the ROW area to the immediate northeast. The 50'X16" sanitary easement appears to have been put in place in lieu of a 1964 alley ROW vacation (record attached). The portion of the same alley ROW that was not vacated in 1964 is now requested for vacation in an application separate from this relinquishment request.

No other owner on the block will be affected by the relinquishment or the alley vacation, as the property is a dead-end portion of an alley T-intersection. The easement is surrounded by Formativ's holdings and the remaining "T" portion of the NE-SW alley.

In general, CPM Bridge Group is likely agreeable to this, but has a few concerns with the request. The comments are focused on the "bridge easement relinquishment explanation" document.

- Letter states that the "...sidewalk is proposed to be replaced in its entirety...". The wall is necessary to support the sidewalk, which provides pedestrian connectivity to Walnut Street. Will this connection be maintained when the existing sidewalk is removed?
- The letter mentions the potential construction of a new "...retaining wall between the building and bridge approach." Who will own/maintain this wall? If the City has any responsibility for it, we will need to be involved in the plan review, material selection, etc.
- Based on conversations with Development Services staff, not sure that the letter's statement "Note that the FFE and grading of this building has been approved by Public Works" is true.
