



- Urban
  - Predominately residential
  - Homes are typically low-scale single- and two-unit residential with some small scale multi-unit residential and commercial.
  - Offers good walkability with short, predictable blocks.





- Low Residential
  - Predominantly single- and two-unit uses
  - Accessory dwelling units are appropriate
- Future Street Type
  - Green Court: Local or Undesignated





- Growth Areas Strategy: All other areas of the city
  - 10% jobs by 2040
  - 20% housing by 2040



- Land Use and Built Form Housing Policy 4: Diversify housing choice through the expansion of accessory dwelling units throughout all residential areas (p. 84).
- Land Use and Built Form Housing Policy 5: Remove barriers to constructing accessory dwelling units and create context-sensitive form standards (p. 84).
