**Department of Transportation and Infrastructure (DOTI) Large General Civil On-Call Construction Services Contracts**

DOTI is seeking to establish a group of qualified On-Call Prime General Contractors available to respond to proposal bidding request for the execution of construction work for the City's infrastructure.

**Purpose and Use of Agreements:**

The purpose of these On-Call contracts is to establish and maintain a pool of qualified On-Call Prime General Contractors available to respond to proposal bidding requests for the execution of DOTI's 3 year, \$1.6 Billion work plan. At a total capacity of \$250M, these contracts will support delivery of at most 16% of this total effort. Each contract has a 23% M/WBE goal creating up to \$57.5M in certified firm participation. **Please note, a separate On-Call construction contract exclusively for Small Business Enterprise (SBE) firms will be advertised in September 2020.** The General Civil Construction On-Call contract will be utilized to construct a variety of improvements to the City and County of Denver's infrastructure typically within City Right-of-Way.

**These improvements may include but are not limited to:** preconstruction services; roadway construction; bridge construction; pavement rehabilitation; bike lane construction; signing and striping construction; traffic signal, lighting, and telecommunication construction; and storm sewer and sanitary sewer construction.

**Future projects that can use these on-calls:** Connecting Auraria; Jewell/Evans bridge; Colorado/Buchtel improvements; Citywide Sidewalks projects; Signal Reconstruction projects; Broadway Multimodal Projects; Hampden Corridor Multimodal improvements; Multiple bike network program projects.

**Procurement:**

Fifteen (15) firms submitted qualification submittals which were reviewed and scored. Of those submittals, ten (10) firms were selected.

**Contracts Description:**

Each contract has a three (3) year term and a capacity of \$25 million. The firms selected for these agreements are listed alphabetically.
