#### AMENDMENT TO EMERGENCY OCCUPANCY AGREEMENT

This AMENDMENT TO EMERGENCY OCCUPANCY AGREEMENT ("Amendment") is made between the CITY AND COUNTY OF DENVER, a municipal corporation and home rule city of the State of Colorado (the "City" or "Government") and JBK HOTELS, LLC, a Delaware limited liability company ("Owner").

WHEREAS, the parties entered into an Emergency Occupancy Agreement dated May 6, 2020 (City Clerk File No. 202054515-00) for the City to use Owner's hotel facility to provide non-congregate sheltering to members of the public on an expedited, emergency basis due to the COVID-19 pandemic (the "Agreement"); and

WHEREAS, the parties wish to amend the Agreement by extending the Term and increasing the contract funds in the amount of One Million Six Hundred Twenty-Two Thousand Six Hundred dollars (\$1,622,600.00);

NOW, THEREFORE, in consideration of the promises and the mutual covenants and obligations herein set forth, the parties agree as follows:

- 1. Article 2 of the Agreement entitled "<u>TERM</u>" is deleted in its entirety and amended to read as follows:
  - **"2.** <u>TERM</u>: The term of this Lease shall begin on the Effective Date, and terminate at 11:59 P.M. on December 31, 2020 ("Term"), *provided, however,* the parties agree that the Term shall not extend beyond the duration of the Public Health Emergency, as that term is defined under the Nationwide Emergency Declaration and the City may terminate this Agreement at any time upon expiration of the Public Health Emergency or as otherwise stated herein."
- 2. The definition for the term "<u>Maximum Contract Amount</u>" under Article 3 of the Agreement is deleted in its entirety and amended to read as follows:

"Notwithstanding any other provisions of the Agreement, the City's maximum payment obligation will not exceed Three Million Five Hundred Fifty-Eight Thousand Five Hundred dollars (\$3,558,500.00) (the "Maximum Contract Amount")."

- 3. Except as herein amended, the Agreement is revived, affirmed and ratified in each and every particular.
- 4. This Amendment will not be effective or binding on the City until it has been fully executed by all required signatories of the City and County of Denver, and if required by Charter, approved by the City Council.
