### 5. General description or background of proposed request. Attach executive summary if more space needed:

Aramark Services was contracted to provide janitorial, sanitation and laundry services at the Colorado Convention Center Alternative Care Facility. This agreement covers those services while the facility is being utilized for an alternative COVID use, and this proposed amendment adds time to cover the continued use of this facility through at least the end of 2020. As background, through a lease between the City and the State, an Alternative Care Facility was established in April of 2020 in response to the COVID-19 pandemic for potential patient overflow. While not utilized to date, the State continues to hold this site at the ready for any potential future surge. Most recently the State and the City exercised the option to extend the lease agreement through the end of the year. This happened administratively as allowed under the lease amendment approved by City Council earlier this year. The State of Colorado has now agreed to maintain the facility through December 31, 2020 and has indicted the possibility of maintaining the facility through March of 2021. These janitorial & laundry services are fully reimbursed by the State through the State services agreement in front of council concurrently with this amendment.
