The facility was established in April of 2020 in response to the COVID-19 pandemic for people experiencing homelessness. This amendment seeks to extend the provision of services through December 31, 2020 with an option to extend through March 31, 2021, add \$2,000,000 to the contract total, and make minor modifications to the scope of work. The auxiliary shelter for men at the Denver Coliseum provides 24/7 sheltering with a capacity of up to 300 guests. Sheltering operations are administered by the Denver Rescue Mission, and this effort includes medical screening of all guests at entry by the Colorado Coalition for the Homeless.
