The word "corporation" also implied a for profit entity, not a nonprofit. Denver College Success Corporation was also getting confused with Denver Scholarship Foundation, and it didn't accurately portray who they are and what they do.						
	As a result, the board of directors wanted to change the name. The Board worked with Taloma Partners, a communications firm and attorney to identify options. Ultimately, the Board voted on Prosperity Denver Fund since it connected to the original branding from the ballot initiative.
