INTRODUCED BY COUNCILMEN

A BILL

FOR AN ORDINANCE RELOCATING THE ALLEY IN BLOCK 2, ROSEDALE SUBDIVISION BY VACATING A PORTION OF THE EXISTING ALLEY SUBJECT TO CERTAIN RESERVATIONS AND DEDICATING A CERTAIN AREA OF LAND IN REPLACEMENT THEREOF.

WHEREAS, the Manager of Public Works of the City and County of

Denver has found and determined that the public use, convenience and necessity

require that the alley in Block 2, Rosedale Subdivision be relocated; and

WHEREAS, the said Manager has found and determined that the relocation of the aforesaid alley shall be accomplished by vacating, subject to certain reservations, a portion thereof and by opening and establishing another area of land to replace that portion of said alley vacated and, subject to approval by ordinance, has vacated a portion of the alley as aforesaid and has laid out, opened and established a new area as a public alley; now, therefore; BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. That the action of the Manager of Public Works in vacating the following described portion of the following described alley in the City and County of Denver, State of Colorado, to-wit:

That portion of the alley in Block 2, Rosedale Subdivision, City and County of Denver, bounded by the South line of West Jewell Avenue on the North and the Easterly extension of the North line of Lot 10, said Block 2, on the South;

be and the same is hereby approved and the described portion of the alley is hereby vacated and declared vacated; provided, however, said vacation shall be subject to the following conditions and reservations:

There is reserved to the utility owners and the City and County of Denver the continued use and the right to construct operate and maintain power, telephone and sanitary sewer lines in the said vacated portion of said alley.

Section 2. That the action of the Manager of Public Works in laying out, opening and establishing as a public alley the following described real property situate, lying and being in the City and County of Denver, State of Colorado, to-wit:

That part of Lot 10, Block 2, Rosedale, described as follows: Beginning at the Northeast corner of said Lot 10; thence Southerly along the East line of said Lot 10 to the Southeast corner thereof; thence Westerly along the South line of said Lot 10 to the Southwest corner thereof; thence Northerly along the West line of said Lot 10, 16 feet; thence Easterly on a line parallel with the South line of said Lot 10 to a point 20 feet West of the East line of said Lot 10; thence Northeasterly to a point on the North line of said Lot 10 and 10 feet West of the Northeast corner thereof; thence Easterly along the North line of said Lot 10 to the point of beginning;

be and the same is hereby approved and said portion of real property is hereby laid out, opened and established and declared laid out, opened and established as a public alley.

Section 3.
