Dear Mayor Hancock,

I'm writing this letter in hopes to be considered as an applicant for the Denver community corrections board. Being able to get this opportunity would mean the world to me and I would work very hard to represent the City and County of Denver as well as our great State of Colorado. To be upfront, I am a previous offender and have been incarcerated in CDOC as well as a resident in community corrections. Let me start from the beginning and give you a summary of how my life changed and where I'm at today.

Attached is a document stating the details of my case. But to summarize, I was convicted of 2nd degree assault (domestic violence). It's embarrassing to say the least, but it's now a part of my life-experience and journey and I'm a better man because of it. I would be more than happy to go into detail of what happened that night or what led me up to that point if needed. For what it's worth, this was my first and only incident of any type of domestic violence. However, my decisions that night hurt someone as well as her family and friends. The one thing I can do now, is take my experience to try to help others with understanding, compassion, and the goal of getting them back on track.

During my time in CDOC, I worked as a tutor to help men pass their GED and have a better understanding of certain subjects. I also designed, surveyed, and oversaw construction of a sanitary sewer service line at Trinidad Correctional Facility's new cooking program building and submitted plans to fix their drainage issues within the complex. I was also a speaker and stand-up comedian for different program graduations and engulfed myself in different college courses and the entrepreneurial program.

After getting out of prison, I was moved into community corrections. During my time in community corrections, I immediately got the first job that would hire me and started taking classes to be an AutoCAD technician. That led me to finally being hired with a prominent engineering firm in Denver after many refusals from different companies because of my record. From there, I went back to school and obtained my bachelor's degree in civil engineering. After working for this amazing company for over 3 years, I decided to start my own business in real estate. That's where Hope Homes began. Hope Homes is a company that buys distressed houses, rehabilitates them, and sells them at the top of the market. What sets this company apart from others, is I donate a minimum of 10% of the profits to a non-profit organization or to the community for people in need. I have done this from day 1 and have never missed donating. To date, I have helped different organizations to include the Colorado Make a Wish Foundation with granting a wish for a 3-year-old with cancer. I'm also a multi-year sponsor with Pro Football camp where I will pay for multiple scholarships for low-income kids that can't afford to go to summer camp.

During this journey, I have also met a young woman in which we have a son together. We have been together almost 4 years and she is amazing. She was in the Peace Corps for many years and working towards becoming a doctor. She keeps me grounded and supports my passions. Ironically, her mother is a Denver judge. I would be lying if I said I was not a concern for the family when I first met their daughter. But over the years, I have gained their trust, respect, and I have no doubt they would give you an honest and positive testimony of my character as a man, father, and significant other.

I believe I would make a great asset to the team because of my unique experiences. I have lived with other offenders and shared with them the many emotions to include happiness, anxiety, positive bonds with others, and depression while being incarcerated. I understand the dynamic because I was living it. I also come from a very poor upbringing. I was in foster care for the first few years of my life and with a poor single mother the rest. To compound things, I had my first son when I was 16 years old and had to get my GED so I could get a job and support my family. I am a testament of how anyone can come out of a troubled situation and still be something great. It's so humbling that I'm able to give back now and share my story with others that turning your life around when the odds are against you, can be done.

Thank you for this rare and amazing opportunity to be able to be an option for a board seat. I promise to be unbiased in any of my decision making and be fair to everyone. I will not let you down.

STATEMENT OF THE CASE AND FACTS

(with trial transcript notations)

Case Number: 13CR1089

Defendant: Christopher Meeks

Christopher Meeks, the defendant, was charged with the first and second degree assault, as well as false imprisonment, of Lita Jackson.¹ After trying his case to a jury, Meeks was found not guilty of first degree assault and false imprisonment, but guilty instead of two counts of second degree assault and thereafter, was sentenced to the mandatory minimum (for a crime of violence) of five years in prison, followed by three years of parole.²

At trial, Lita Jackson (the alleged victim) and Meeks (the defendant) both testified consistently that on the evening at issue, the couple were initially enjoying each other's company and drinking heavily at Meeks home. However, after Jackson searched through Meeks' cellular telephone and discovered that he had been communicating with another woman, she became enraged (as the two had recently dissolved their serious long-term relationship) and began attacking the defendant and even pointed a firearm at his head. In an effort to disarm Jackson and defend himself from her assault, Meeks struck the alleged victim a few times in the face and forcibly held her down. Meeks then managed to push Jackson outside of his home, locking the door behind him.

Undeterred, however, Jackson climbed over the defendant's fence, falling to the ground in the process, before entering his home through an upstairs window. Once inside, the couple agreed to a truce and eventually fell asleep in the same bed together. Hours later, Jackson awoke to an unsightly black eye (which the defendant believed he might have caused during their physical altercation) and an intense soreness in her side (which turned out to be a collapsed lung) as well as various scratches and bruises which Jackson believed she suffered after falling off of the defendant's fence.

Upset with her physical condition and still jealous and angry over Meeks' supposed infidelity, Jackson contacted her previous boyfriend (David Laffler) and claimed that the defendant had assaulted her, in hopes that Laffler would "kick [the defendant's ass]." Instead, however, Laffler contacted Jackson's brother who, in turn, alerted the police. When the police arrived, Jackson was taken to the hospital (and continued to claim the defendant had beaten and choked her) while Meeks was arrested and charged with various crimes of domestic violence.

(Case Notes): It should be noted that Ms. Jackson recanted on the initial story she told police and admitted in trial that she was the initial aggressor and that she pointed a gun at Mr. Meeks' head. Since the case with Mr. Meeks, Ms. Jackson has been convicted of two separate cases of domestic violence against individuals other than Mr. Meeks, to include: 14M3070 Domestic Violence related Second Degree Criminal Tampering with intent to cause injury, inconvenience or annoyance AND 13M2272 Carrying a Concealed Weapon. In addition, two of Mr. Meeks' other long term girlfriends spoke at his sentencing hearing stating that Mr. Meeks was never abusive towards them at any point during their relationship.
