7 **For an ordinance extending the date for the housing stability strategic advisors to**  
8 **hold its first meeting.**

9  
10 **BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

11 **Section 1.** That section 27-163, D.R.M.C. shall be amended by deleting the language stricken  
12 and adding the language underlined, to read as follows:

13 Sec. 27-163. - Meetings and procedures.

14 (a) The schedule of regular meetings of the housing stability strategic advisors shall be established  
15 by a majority of the membership, but the schedule must provide for at least six (6) regular meetings  
16 per year. Additional meetings shall be called as needed by the chair of the housing stability strategic  
17 advisors. The first meeting of the housing stability strategic advisors shall occur no later than  
18 ~~November 1, 2020~~ January 31, 2021.

19 (b) All meetings of the housing stability strategic advisors shall be subject to city requirements for  
20 open meetings, as set forth in article 111 of chapter 2 of the Code. Participation and voting in housing  
21 stability strategic advisors' business by members of the housing stability strategic advisors shall be  
22 subject to the requirements and limitations of the Code of Ethics, as set forth in article IV of chapter 2  
23 of the Code.

24 (c) The housing stability strategic advisors may adopt additional bylaws and procedures for the  
25 conduct of its meetings and the performance of its duties as set forth in section 27-164.

26 **Section 2.** That this ordinance shall take effect immediately upon final publication.
