## BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

WHEREAS, the City and County of Denver, Colorado (the "City") previously adopted Ordinance No. 20181502 Series of 2019 (the "Original Ordinance") authorizing and approving the City's sponsorship of the Metro Mortgage Assistance Plus Program (the "Program") to provide competitive mortgage loans which will be coupled with down payment and closing cost assistance in connection with financing mortgage loans for low-and moderate-income families intended for use as the sole place of residence by the owners or intended occupants thereof; and

**WHEREAS**, capitalized terms used herein but not otherwise defined shall have the meaning assigned to such terms in the Original Ordinance; and

**WHEREAS**, the Original Ordinance delegated to the Chief Financial Officer or the Executive Director of the City's Office of Economic Development certain authority to operate the Program; and

**WHEREAS**, on September 27, 2019 Executive Order 145 was signed, thereby creating the Department of Housing Stability ("HOST") in the City, and providing the Executive Director/Chief Housing Officer of HOST the authority to govern in matters requiring action in response to housing stability, homelessness resolution, and housing opportunity, except where authority is otherwise granted by applicable federal, state or local law or regulation; and

WHEREAS, administration of the Program has been moved from the Department of Finance ("Finance") and the Office of Economic Development to Finance and HOST; and

1 2	WHEREAS, the Original Ordinance appointed George K. Baum & Company ("George K. Baum") as the program advisor of the Program; and
3 4 5	WHEREAS, George K. Baum sold certain of its assets to Stifel, Nicolaus & Company, Incorporated ("Stifel"), and Stifel assumed George K. Baum's rights and obligations thereunder; and
6 7	WHEREAS, the Original Ordinance appointed CSG Advisors ("CSG") as the program monitor of the Program; and
8 9 10	WHEREAS, Caine Mitter & Associates, Incorporated ("Caine Mitter") has, since the adoption of the Original Ordinance, been retained to serve as the program monitor of the Program; and
11 12 13	WHEREAS, the City desires to amend the Original Ordinance to change the delegation of authority to operate the Program from Finance or the Office of Economic Development to Finance or HOST; and
14 15	WHEREAS, the City desires to amend the Original Ordinance to change all references from George K. Baum to Stifel; and
16 17	WHEREAS, the City desires to amend the Original Ordinance to change all references from CSG to Caine Mitter;
18 19	NOW, THEREFORE, BE IT ENACTED BY THE CITY COUNCIL OF THE CITY AND COUNTY OF DENVER, COLORADO:
<ul><li>20</li><li>21</li><li>22</li></ul>	<b>Section 1.</b> Section 4 of the Original Ordinance is hereby amended and restated to change the Executive Director of the City's Office of Economic Development to the Executive Director/Chief Housing Officer of HOST as follows:
23	The form, terms and provisions of the Program Documents are hereby

The form, terms and provisions of the Program Documents are hereby approved; with such changes and modifications as the appropriate officers of the City deem necessary and advisable; and the City shall execute and deliver the Program Documents, in substantially the form heretofore filed with the Council and to be filed with the City Clerk; and the Chief Financial Officer or Executive

Director/Chief Housing Officer of the City's Department of Housing Stability is hereby authorized and directed to execute and deliver the Program Documents.

**Section 2.** Section 9 of the Original Ordinance is hereby amended and restated to add the Executive Director/Chief Housing Officer of HOST as follows:

The Council hereby delegates to the Chief Financial Officer or the Executive Director/Chief Housing Officer of the Department of Housing Stability, the power to execute any and all documents relating to the Program and the power to execute any and all amendments to the Program Documents, including extensions and modifications to the terms of the Program, and take any actions necessary to administer and manage the Program consistent with the transactions contemplated by this Ordinance.

- Section 3. All reference to "George K. Baum & Company" in the Original Ordinance are hereby changed to "Stifel, Nicolaus & Company, Incorporated."
  - **Section 4.** All reference to "CSG Advisors" in the Original Ordinance are hereby changed to "Caine Mitter & Associates, Incorporated."
    - **Section 5.** Notwithstanding anything contained in the Original Ordinance, the Program shall continue to serve and shall serve persons and families that earn 150% or less of the area median income for the City and County of Denver, Colorado.
    - **Section 6.** All actions consistent with the provisions of this Ordinance heretofore taken by the Council and the officers of the City directed toward the Program are hereby ratified, approved and confirmed.
    - **Section 7.** If any section, paragraph, clause or provision of this Ordinance shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause or provision shall not affect any of the remaining provisions of this Ordinance.
    - **Section 8.** All bylaws, orders, resolutions, ordinances, or parts thereof, inconsistent herewith are hereby repealed to the extent only of such inconsistency, and if so repealed, no other bylaw, order, resolution, ordinance, or part thereof, shall be revived. This repealer shall not be construed as reviving any bylaw, order, resolution or ordinance, or part thereof.
