Purpose of providing paid time off. 15 To comply with Colorado Senate Bill 20-205, the "Healthy Families and Workplaces Act" (f) as set forth in Colorado Revised Statute 8-13.3-401 et seg. 16 17 18 **Section 2.** That a new Subsection (d) of section 18-123 is hereby added as follows: 19 20 Sec. 18-123. - Eligibility. 21 22 (d) All on-call and part-time employees who are regularly scheduled to work less than twenty 23 (20) hours per week shall receive sick leave pursuant to the Colorado Healthy Families and Workplaces Act at the rate of one hour of leave per 30 hours worked. Any unused 24 leave accumulated by on call and part-time employees scheduled to work twenty (20) 25 hours per week pursuant to the Colorado Healthy Families and Workplace Act shall not 26 be payable to the employee upon separation, as these employees are not "eligible" for 27 28 such payout pursuant to Section 18-127. 29 30 **Section 3.** That a new Subsection (c) of section 18-131 is hereby added as follows: 31 32 Sec. 18-131. - Eligibility. 33 34 All on-call and part-time employees who are regularly scheduled to work less than twenty (c) 35 (20) hours per week shall receive sick leave pursuant to the Colorado Healthy Families 36 and Workplaces Act at the rate of one hour of leave per 30 hours worked. Any unused leave accumulated by on call and part-time employees scheduled to work twenty (20) 37 38 hours per week pursuant to the Colorado Healthy Families and Workplace Act shall not 39 be payable to the employee upon separation, as these employees are not "eligible" for such payout pursuant to Section 18-134. 40 41 42
