Contract Extension Request Details

Service Employees International Union Local 105 (SEIU)

Collective bargaining agreement and wages are being negotiated with HSS as part of the extension (100+ members are part of this contract).

Overall reason for extension with HSS is to provide security services in core City and County of Denver buildings, 19 in total

- RFP for DGS Security Services came before Council October 2020
- Allied Universal was awarded a contract.
- Council voted against Allied receiving a contract for security services (DGS)
- GS seeks clear understanding from Stakeholders and path forward, prior to re-issuing RFP
