SECOND AMENDATORY AGREEMENT

This **SECOND AMENDATORY AGREEMENT** is made between the **CITY AND COUNTY OF DENVER**, a municipal corporation of the State of Colorado (the "City") and **SECURITAS SECURITY SERVICES USA, INC.,** a Delaware corporation doing business at 9 Campus Drive, Parsippany, NJ 07054 (the "Contractor" or "Sub-Awardee"), jointly ("the Parties").

RECITALS:

- **A.** The Parties entered into Agreement dated June 29, 2020 and a First Amendatory Agreement dated October 8, 2020 (the "Agreement") to provide security services required by the Agreement.
- **B.** The Parties wish to amend the Agreement to increase the maximum contract amount.

NOW THEREFORE, in consideration of the premises and the Parties' mutual covenants and obligations, the Parties agree as follows:

1. Section 4 of the Agreement entitled "<u>COMPENSATION AND PAYMENT</u>" Sub-paragraph d(1) entitled "<u>Maximum Contract Amount</u>" is amended to read as follows:

"d. Maximum Contract Amount:

- (1) Notwithstanding any other provision of the Agreement, the City's maximum payment obligation will not exceed TWO MILLION FIVE HUNDRED THOUSAND DOLLARS AND NO CENTS (\$2,500,000) (the "Maximum Contract Amount"). The City is not obligated to execute an Agreement or any amendments for any further services, including any services performed by the Sub-Awardee beyond that specifically described in Exhibit A. Any services performed beyond those in Exhibit A, or as directed by Director in writing, are performed at the Sub-Awardee's risk and without authorization under the Agreement."
- 2. As herein amended, the Agreement is affirmed and ratified in each and every particular.
- **3.** This Second Amendatory Agreement will not be effective or binding on the City until it has been fully executed by all required signatories of the City and County of Denver, and if required by Charter, approved by the City Council.
