19	a. The land area hereinafter described is presently classified as U-SU-C.			
20	b. It is proposed that the land area hereinafter described be changed to U-SU-C1.			
21	Section 2. That the zoning classification of the land area in the City and County of Denver			
22	described as follows shall be and hereby is changed from U-SU-C to U-SU-C1:			
23 24 25	LOTS 13 and 14, BLOCK 3, HARKNESS HEIGHTS, CITY AND COUNTY OF DENVER, STATE OF COLORADO			
26	in addition, thereto those portions of all abutting public rights-of-way, but only to the centerline			
27	thereof, which are immediately adjacent to the aforesaid specifically described area.
