In response to the city's need for providing shelters for people experiencing homelessness during the declared emergency on the basis of COVID-19, the city established various shelter locations. Because of the shelter expansion, additional security personnel are needed as the citywide security contractor does not have capacity to fulfill the need. Securitas Security Services has been fulfilling these critical security personnel services at congregate and non-congregate shelter locations. Securitas will be taking over additional sheltering locations that were being serviced under Universal Protection Services dba Allied Universal. In order to continue service as this pandemic is on-going, an increase to the maximum compensation is required alongside a term extension.

The Contractor shall provide 24/7 security personnel services at congregate and non-congregate shelters in response to the city establishing the shelters to reduce the spread of COVID-19 among those experiencing homelessness.

Pursuant to D.R.M.C Sec. 20-64; the Manager of General Services approved foregoing the bidding procedures in order to procure this service through an emergency purchase. The General Services Contracts Office did an information solicitation to establish the ability to perform these services and obtain pricing to accommodate the staffing need.
