THIRD AMENDATORY AGREEMENT

This **THIRD AMENDATORY AGREEMENT** is made between the **CITY AND COUNTY OF DENVER**, a municipal corporation of the State of Colorado (the "City") and **SECURITAS SECURITY SERVICES USA, INC.,** a Delaware corporation doing business at 9 Campus Drive, Parsippany, NJ 07054 (the "Contractor" or "Sub-Awardee"), jointly ("the Parties").

RECITALS:

- A. The Parties entered into Agreement dated June 29, 2020, a First Amendatory Agreement dated October 8, 2020, and a Second Amendatory Agreement dated December 9, 2020 (collectively, the "Agreement") to provide the products and/or services required by the Agreement.
- **B.** The Parties wish to amend the Agreement to extend the term, and increase the maximum contract amount.

NOW THEREFORE, in consideration of the premises and the Parties' mutual covenants and obligations, the Parties agree as follows:

- 1. Section 3 of the Agreement entitled "<u>TERM</u>" is amended to read as follows:
- **TERM**: The Agreement will commence on June 15, 2020 and will expire on June 30, 2021 (the "Term"). Subject to the Executive Director's prior written authorization, the Contractor shall complete any work in progress as of the expiration date and the Term of the Agreement will extend until the work is completed or earlier terminated by the Executive Director.
- 2. Section 4 of the Agreement entitled "<u>COMPENSATION AND PAYMENT</u>" Sub-paragraph d(1) entitled "<u>Maximum Contract Amount</u>" is amended to read as follows:

"d. <u>Maximum Contract Amount:</u>

- (1) Notwithstanding any other provision of the Agreement, the City's maximum payment obligation will not exceed SEVEN MILLION FIVE HUNDRED THOUSAND DOLLARS AND NO CENTS (\$7,500,000) (the "Maximum Contract Amount"). The City is not obligated to execute an Agreement or any amendments for any further services, including any services performed by the Sub-Awardee beyond that specifically described in Exhibit A. Any services performed beyond those in Exhibit A, or as directed by Director in writing, are performed at the Sub-Awardee's risk and without authorization under the Agreement."
- 3. As herein amended, the Agreement is affirmed and ratified in each and every particular.
- **4.** This Third Amendatory Agreement will not be effective or binding on the City until it has been fully executed by all required signatories of the City and County of Denver, and if

required by Charter, approved by the City Council.
