A RESOLUTION

Approving and providing for the execution of a proposed Grant Agreement between the City and County of Denver and the State of Colorado concerning the “Victims of Crime Act” program and the funding therefor.

WHEREAS, the City and County of Denver has given due consideration to said proposed Grant Agreement;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. The proposed Grant Agreement, under CFDA 16.575, between the City and County of Denver and the Colorado Department of Public Safety Division of Criminal Justice, for the “Victims of Crime Act” program, which is identified as Grant Number 20-VA-21-450-02, a copy of which is duly filed with the City Clerk, Filing No. 202057295, be and hereby is approved in all respects.

Section 2. The payments made by the State of Colorado, to the City pursuant to and under the Grant Agreement shall be deposited into the Treasury of the City and credited to Special Fund No. 12000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

Section 3. That it be and is hereby found and determined that the budget summary of said program, to be expended by the District Attorney is as follows:

Expenditures of said funds are authorized from January 1, 2021 to December 31, 2022.
