This project will provide emergency outdoor sheltering and serve individuals currently experiencing homelessness at two managed sites by providing safe outdoor space to socially distance, access to hygiene facilities, and supportive staffing to prevent, prepare for, and respond to COVID-19.

One location will be at the Denver Community Church (1595 Pearl St., Denver, CO 80203) and the second site is yet to be determined. This SOS funding assists strategies to prevent the spread of COVID-19 among people experiencing unsheltered homelessness by providing safe space to socially distance, access to hygiene facilities, and supportive staffing.
