

Roth Property Maintenance, L.L.C. 201419545-04

Overview:

Roth Property Maintenance, L.L.C. (RPM) is under contract to provide janitorial services at various city-owned facilities, excluding Denver International Airport. The current contract is set to expire on February 28, 2021, with a maximum contract amount of \$33,500,000. The General Services Contracts Office is requesting a formal amendment to add two months of service with a new end date of April 30, 2021, with no change to contract maximum or other terms and conditions. This extension allows the General Services Contracts Office the necessary time to take the new janitorial services agreements through the contracting and City Council process for approval.

Procurement Information for New Janitorial Contracts

Overview:

The citywide service was broken into seven portfolios: five (5) portfolios based on General Services Facilities Management teams and two Parks & Recreation portfolios consisting of recreation centers and parks locations. Thirteen (13) proposals were received, and nine (9) were deemed responsive. The selection committee, consisting of stakeholder agencies including General Service, Parks & Recreation, and DOTI, evaluated each contractor based on the following criteria:

- Organization background
- Organization capacity
- Service delivery plan
- Staff training plan
- Pricing
- Required document submittal (administrative)
 - DSBO Utilization Plan
 - Technical Requirements

The selection committee made two awards to the top two highest scored contracts; Roth Property Maintenance and KG Clean, Inc. By awarding the top two contractors, the city ensures a continued high level of service over the term of the contract and ensures the city's ability to quickly and appropriately respond to cleaning and disinfection needs associated with the pandemic. Both contractors were awarded one of the Parks & Recreation portfolios and at least one General Services portfolio. Roth Property Maintenance and KG Clean have committed to 100% MWBE participation goal.

General Services is finalizing contract negotiations with both Roth Property Maintenance and KG Clean, and it is anticipated that these contracts will move forward to the FINGOV committee on March 9, 2021.
