7 8	WHEREAS, the City Council desires to amend the Denver Zoning Code to implement the			
9	land use recommendation relating to the creation of the Bungalow Conservation Overlay (CO-6)			
10	and to clarify certain standards contained in the Potter Highlands Conservation Overlay (CO-4); and			
11	WHEREAS, a map amendment to rezone certain property into the Bungalow Conservation			
12	Overlay (CO-6) is being processed contemporaneously herewith and will have a public hearing at			
13	City Council on the same night as the public hearing on this Ordinance; and			
14	WHEREAS, the City Council has determined on the basis of evidence and testimony			
15	presented at the public hearing that amending the Denver Zoning Code as set forth herein is			
16	consistent with the City's adopted plans, furthers the public health, safety and general welfare, wil			
17	result in regulations and restrictions that are uniform within the applicable zone districts, and that the			
18	CO-6 and CO-4 districts contain distinctive building features.

21	Section 1. The changes to the Denver Zoning Code as set forth in Clerk File No. 20210015			
22	as filed with the Denver City Clerk on February 22, 2021, and available in the office and on the web			
23	page of City Council are hereby adopted and made an official part of the Denver Zoning Code. The			
24	changes amend certain provisions of the Denver Zoning Code to establish a new conservation			
25	overlay zone district referred to as Bungalow Conservation Overlay (CO-6) in furtherance of			
26	implementation of Comprehensive Plan 2040 and Blueprint Denver 2019; and clarify application of			
27	standards to rooftops, second story decks, and dormers in the Potter Highlands Conservation
