12	Section 1. Article V of Chapter 6 shall be amended by adding the language underlined and

28	and delivery, and consumption of medical or retail marijuana, the director may issue a local license					
29	or permit of any of the following classes, subject to the provisions and restrictions provided in this					
30	article V and the Colorado Marijuana Code:

16	<u>(a) Marijuana hospitality businesses—authorized. Beginning July 1, 2021, a local marijuana</u>				
17	hospitality business license may be issued to allow for the on-premises consumption of marijuana				
18	at either a fixed location or mobile premises, subject to the provisions of this article V and the				
19	Colorado Marijuana Code.				
20	(b) Licensing requirements—all locations. In addition to the provisions applicable to all				
21	licenses, all marijuana hospitality business licensees shall comply with the following provisions:				
22	(1) A marijuana hospitality business licensee shall not permit the use or consumption				
23	of regulated marijuana between the hours of 2:00 a.m. and 7:00 a.m. daily.				
24	(2) A marijuana hospitality business licensee shall not sell, transfer, or distribute, with				
25	or without remuneration, or allow the sale, transfer, or distribution, with or without remuneration, of				
26	marijuana, marijuana concentrate, or marijuana products on the licensed premises.				
27	(3) A marijuana hospitality business licensee shall not engage in or allow any activity				
28	that would require an additional license under this article, including but not limited to planting,				
29	growing, harvesting, storing, drying, trimming, processing or manufacturing marijuana, marijuana				
30	concentrate, or marijuana products on the licensed premises. Nothing in this subsection prohibits a				
31	marijuana hospitality business from storing marijuana consumer waste on the licensed premises, in				
32	compliance with state law.				
33	(4) A marijuana hospitality business licensee shall not allow any person to consume 2				

or display marijuana, marijuana concentrate, or marijuana products outside of a consumption area 1 2 or any place that is visible from outside of the consumption area. 3 (5) A marijuana hospitality business may allow smoking of marijuana in indoor and 4 outdoor portions of the licensed premises. Marijuana smoking indoors and outdoors must occur in 5 compliance with an Odor Control Plan filed pursuant to section 4-10 of this Code, and approved by 6 the department of public health and environment. 7 (6) A marijuana hospitality business licensee shall ensure that all areas of ingress and 8 egress to the consumption areas are clearly identified and posted with signs and warnings required 9 by state law or the department. 10 (7) A marijuana hospitality business licensee shall not allow on-duty employees of the 11 business to consume any marijuana, marijuana concentrate, or marijuana product on the licensed 12 premises. 13 (8) A marijuana hospitality business licensee shall not allow the consumption of 14 alcohol or smoking of tobacco or tobacco products on the licensed premises. 15 (9) A marijuana hospitality business licensee shall not allow any person under the age 16 of twenty-one (21) on the licensed premises. Government-issued identification must be required 17 from all patrons before the patron is allowed access into the licensed premises. 18 (10) A marijuana hospitality business licensee shall not permit the use or consumption 19 of marijuana, marijuana concentrate, or marijuana product by a patron who displays any visible 20 signs of intoxication. 21 (11) If an emergency requires law enforcement, firefighters, emergency medical 22 service providers, or other public safety personnel to enter a marijuana hospitality business, a 23 marijuana hospitality business licensee shall ensure that all employees and patrons of the business 24 cease all consumption and other activities until such personnel have completed their investigation 25 or services and have left the licensed premises. 26 (c) Licensing requirements-mobile premises. In addition to the requirements for all 27 marijuana hospitality businesses identified in subsection (b), marijuana hospitality businesses on 28 mobile premises shall comply with the following provisions: 29 (1) A mobile marijuana hospitality business licensee shall not permit the consumption 30 of marijuana on the moibile premises if the mobile premises is stopped, standing, or parked for more 31 than 30 minutes. 32 (2) A mobile marijuana hospitality business shall file a route log with the department 33 identifying the origin and destination of all routes, and all stops in between the origin and the 3

1	destination, at least seven (7) business days prior to the scheduled departure. A marijuana			
2	hospitality business shall not change or deviate from the route log without notifying the department			
3	at least seven (7) business days prior to scheduled departure. Identified origins, destinations, and			
4	stops may not include any of the following locations:			
5	a. Schools;			
6	b. Child care establishments;			
7	c. Alcohol or drug treatment facilities; or			
8	d. City-owned recreation centers and pools.			
9	(3) A mobile marijuana hospitality business shall make the route log available to any			
10	city inspector or police officer upon request.			
11	(4) A mobile marijuana hospitality business shall ensure that the motor vehicle has no			
12	external markings, words, or symbols that constitute advertising as defined in section 6-204(1).			
13	(d) Proximity restrictions. No marijuana hospitality business license shall be issued if the			
14	proposed location is within 1,000 feet of one of more of the following locations:			
15	(1) Any school, with the distance computed by direct measurement in a straight line			
16	from the nearest legal parcel line of the land used for the school to the nearest external portion of			
17	the building in which the marijuana hospitality business is proposed to be located.			
18	(2) Any child care establishment, with the distance computed by direct measurement			
19	in a straight line from the nearest legal parcel line of the land used for the child care establishment			
20	to the nearest external portion of the building in which the marijuana hospitality business is proposed			
21	to be located.			
22	(3) Any other marijuana hospitality business licensed pursuant to this article V, with			
23	the distance computed by direct measurement in a straight line from the nearest external portion of			
24	the building within which one (1) marijuana hospitality business is located to the nearest external			
25	portion of the building in which the other marijuana hospitality business is proposed to be located.			
26	In the event that the department receives two or more applications for a marijuana hospitality			
27	business with proposed locations within one thousand (1,000) feet of each other, the director shall			
28	act upon only the first complete application received and shall not issue a license to all subsequent			
29	applications.			
30	(4) Any alcohol or drug treatment facility, with the distance computed by direct			
31	measurement in a straight line from the nearest external portion of the building in which the alcohol			
32	or drug treatment facility is located to the nearest external portion of the building in which the			
33	marijuana hospitality business is proposed to be located.			

1 (5) Any city-owned recreation center, with the distance computed by direct 2 measurement in a straight line from the nearest external portion of the building in which the 3 recreation center is located to the nearest external potion of the building in which the marijuana 4 hospitality business is proposed to be located. 5 (6) Any city-owned outdoor pool, with the distance computed by direct measurement 6 in a straight line from the fence or barrier of the outdoor pool to the nearest external potion of the 7 building in which the marijuana hospitality business is located. 8 (7) The proximity restrictions identified in this subsection (d) shall not apply to the 9 mobile premises of a marijuana hospitality business. 10 (e) Location restrictions. No marijuana hospitality business license shall be issued at one or 11 more of the following locations: 12 (1) The licensed premises of another medical or retail marijuana business license. The 13 marijuana hospitality business and other marijuana business shall provide separate ingress and 14 egress to each licensed premises. 15 (2) The licensed premises of any business containing a business licensed pursuant to 16 Articles 3, 4, or 5 of Title 44 of the Colorado Revised Statutes. The marijuana hospitality business 17 and other marijuana business shall provide separate ingress and egress to each licensed premises, 18 and shall comply with all state laws. 19 (3) Any location deemed public property and owned by the City. 20 (4) Any location that is situated in a residential zone district as defined by the Denver 21 Zoning Code or Former Chapter 59. 22 (5) The location restrictions identified in this subsection (e) shall not apply to the mobile 23 premises of a marijuana hospitality business. 24 (f) Public hearing-required. A public hearing in compliance with section 6-209 shall be 25 required prior to the issuance of a marijuana hospitality business license at a fixed location, but shall 26 not be required for an application proposing to operate a marijuana hospitality business solely on a 27 mobile premises. The requirements for public notice, posting, publication, conduct, results of 28 investigation, and decision of the director shall be the same as those for medical and retail marijuana 29 stores. 30 Sec. 6-218. – Reserved Retail marijuana hospitality and sales business license. 31 (a) Licensing requirements. Beginning July 1, 2021, a local retail marijuana hospitality and 32 sales business license may be issued to allow for the sale and on-premises consumption of 33 regulated marijuana at a fixed location, subject to the provisions of this article V and the Colorado

- Marijuana Code. In addition to the provisions applicable to all licenses, all retail marijuana hospitality
   and sales business licensees shall comply with the following provisions:
- 3 (1) A retail marijuana hospitality and sales business licensee shall not permit the sale,
   4 transfer, distribution, use, or consumption of regulated marijuana between the hours of 2:00 a.m.
   5 and 7:00 a.m. daily.
- 6 (2) A retail marijuana hospitality and sales business licensee shall not engage in or
  7 allow any activity that would require an additional license under this article, including but not limited
  8 to planting, growing, harvesting, drying, trimming, processing or manufacturing marijuana,
  9 marijuana concentrate, or marijuana product on the licensed premises.
- (3) A retail marijuana hospitality and sales business licensee shall not allow any
   person to consume or display marijuana, marijuana concentrate, or marijuana product outside of a
   consumption area or any place that is visible from outside of the consumption area.

   regulated marijuana in indoor and outdoor portions of the licensed premises. Marijuana smoking
   indoors and outdoors must occur in compliance with an Odor Control Plan filed pursuant to section
   <u>4-10 of this Code and approved by the department of public health and environment.</u>
- 17 (5) A retail marijuana hospitality and sales business licensee shall ensure that all
   18 areas of ingress and egress to the consumption areas are clearly identified and posted with signs
   19 and warnings required by state law.
- 20 (6) A retail marijuana hospitality and sales business licensee shall not allow on-duty
   21 employees of the business to consume any marijuana, marijuana concentrate, or marijuana product
   22 within the licensed premises of the business.
- 23 (7) A retail marijuana hospitality and sales business licensee shall not allow the
   24 consumption of alcohol or smoking of tobacco or tobacco products on the licensed premises.
- (8) A retail marijuana hospitality and sales business licensee shall not allow any
   person under the age of twenty-one (21) into the licensed premises. Government-issued
   identification must be required from all patrons before the patron is allowed access into the licensed
   premises.
- (9) A retail marijuana hospitality and sales business licensee shall not permit the use
   or consumption of marijuana, marijuana product, or marijuana concentrate by a patron who displays
   any visible signs of intoxication.
- 32 (10) A retail marijuana hospitality and sales business licensee shall not transfer, sell,
   33 or otherwise distribute more regulated marijuana in a single transaction to a consumer than the

<u>lawful amounts related to possession and sale set forth in state law. A single transaction includes</u>
 <u>multiple transfers, sales, or distributions to the same consumer during the same business day where</u>
 <u>the medical or retail marijuana store employee knows or reasonably should know that such transfer,</u>
 <u>sale, or distribution would result in that consumer possessing or being sold more than the amounts</u>
 set forth in state law.

6 (11) If an emergency requires law enforcement, firefighters, emergency medical
 7 service providers, or other public safety personnel to enter a retail marijuana hospitality and sales
 8 business, a retail marijuana hospitality and sales business licensee shall ensure that all employees
 9 and patrons of the business cease all consumption and other activities until such personnel have
 10 completed their investigation or services and have left the licensed premises.

11 (12) Beginning January 1, 2022, retail marijuana hospitality and sales business 12 licensees shall install and use a safe in a limited access area, which shall be incorporated into the 13 building structure or securely attached thereto, for overnight storage of all processed cannabis and 14 cash. For marijuana-infused products that must be kept refrigerated or frozen, the establishment 15 may lock the refrigerated container or freezer, so long as the appliance is affixed to the building 16 structure. Alternatively, a business may utilize security devices such as vaults, strong rooms or other 17 security features that are functionally equivalent to a safe as determined by Department rule.

(b) Proximity restrictions. No retail marijuana hospitality and sales business license shall be
 issued if the proposed location is within 1,000 feet of one of more of the following locations:

(1) Any school, with the distance computed by direct measurement in a straight line
 from the nearest legal parcel line of the land used for the school to the nearest external portion of
 the building in which the retail marijuana hospitality and sales business is proposed to be located.

(2) Any child care establishment, with the distance computed by direct measurement
 in a straight line from the nearest legal parcel line of the land used for the child care establishment
 to the nearest external portion of the building in which the retail marijuana hospitality and sales
 business is proposed to be located.

(3) Any other retail marijuana hospitality and sales business licensed pursuant to this
 article V, with the distance computed by direct measurement in a straight line from the nearest
 external portion of the building within which one (1) retail marijuana hospitality and sales business
 is located to the nearest external portion of the building in which the other retail marijuana hospitality
 and sales business is proposed to be located. In the event that the department receives two or more
 applications for a retail marijuana hospitality and sales business with proposed locations within one
 thousand (1,000) feet of each other, the director shall act upon only the first complete application

received and shall not issue a license to all subsequent applications.
 (4) Any alcohol or drug treatment facility, with the distance computed by direct

   requirements for public notice, posting, publication, conduct, results of investigation, and decision
   of the director shall be the same as those for medical and retail marijuana stores.

- (b) Cease operations—required. Except where the director has received a complete renewal
   application along with the requisite fees, it shall be unlawful for any person to manufacture, test,
   <u>consume</u>, receive orders for, sell, distribute, transfer, transport, or otherwise remove cannabis from

1 the licensed premises of a medical or retail marijuana business, or allow any other person to perform

2 these acts, after the expiration date recorded upon the face of any local license issued pursuant to

3 this article V for that location.
