A BILL

For an ordinance making rescissions from and appropriations in the General Fund.

WHEREAS, the Department of Excise and Licenses seeks to amend the Denver Revised Municipal Code through companion ordinances CB21-0216 and CB21-0217 to allow for the licensing and operation of retail marijuana hospitality business and marijuana delivery permits, and to update the DRMC in Chapter 6, Article V- Denver Marijuana Code; and

WHEREAS, the Department of Excise and Licenses will require one-time investments to Accela, the software it uses for permits, licenses, and code enforcement, to support the administration of the changes authorized through said companion ordinances; and

WHEREAS, the new marijuana licenses authorized through the companion ordinances will generate new revenue to the City's General Fund;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. From appropriations heretofore made from the General Fund listed or indicated in the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded" and transferred to the General Fund:
