5. General description or background of proposed request. Attach executive summary if more space needed:

In late 2020, the Colorado General Assembly passed State Bill 20B-001, which authorized the waiver of annual retail food license fees for restaurants and food vendors through December 2021 and allows counties to contract with the Colorado Department of Public Health and Environment (CDPHE) to receive state funding reimbursement.

This state bill applies specifically to retail food establishments, meaning any retail operation that serves, stores, prepares or packages food for sale for consumption to consumers, either directly or indirectly through a delivery service. The bill does not cover other types of food licenses, such as wholesale licenses (including caterers) and food trucks.

As a result of the bill passage, the City and County of Denver announced in January that it would be waiving the 2021 renewal fees for the retail food establishment licensees, which range from approximately \$125-\$400 per location. These fees provide the funds to support food safety inspections, licensing and enforcement of rules and regulations to protect public safety. As of January, there were a total of 1,571 licensed retail food establishments in the City and County of Denver

This IGA will reimburse the City and County Denver for restaurant licensing fees that have been waived in 2021 in accordance with state law. CDPHE has already agreed to reimburse the City in the amount of \$691,826.25 to cover our anticipated revenue loss from this fee waiver program for retail food establishments. Fee waiver or other pandemic-related benefit programs for other license types are not authorized by 20B-001, and are therefore ineligible for reimbursement from the state under this agreement.
