5. General description or background of proposed request. Attach executive summary if more space needed:

The USDA Forest Service has been collecting fees on the Mt. Evans Road since the 1990's. Denver has had formal collection agreements in place to do this since that time. The Forest Service controls the land around Summit and Echo lake Mountain Parks and has operated an information/fee booth at Echo Lake on Denver property since the 1990's. A complete list of the service provided are in the agreement and include:

- Providing clean, safe well maintained facilities
- Providing high quality visitor service
- Providing a variety of recreational opportunities
- Enhancing resources protection

The total amount collected will be under \$500K, the USDA Forest Service will deduct \$75,000 per year to collect the fee and provide site maintenance. Denver's annual revenue after expenses will vary between \$75,000 and \$150,000 per year depending on weather and use levels. The revenue after expenses is deposited in the Mountain Parks Special Revenue Fund. The SRF is used the operation and maintenance of Denver Mountain Parks including Summit and Echo Lake.
