My name is Winter, and I am a constituent of District 7. I am emailing to urge you to vote yes on Bill 21-0437, a bill for an ordinance designating 123 East Speer Blvd. as a structure for preservation. In a week, I will be graduating with my Master of Science in Historic Preservation degree from CU Denver. In the past two years of my graduate education, I have learned the importance of preserving buildings, not just for their historical and architectural significance, but for their environmental benefits. 123 E Speer is a prime example of brutalist architecture and it sits on a prominent corner making it an iconic piece of Speer. Although brutalism is not widely loved right now, does not mean it won't be loved in the future. Lest we forget that in the mid-century, people thought of Victorian architecture as ugly, and today it is widely loved.

I also feel that denying the historic designation of 123 E Speer and allowing for its demolition is a harmful choice for the environment. As an advocate for sustainability, I would hope that you would recognize the mass amount of waste it would be to demolish the building. There are other pathways forward, including an adaptive reuse of the building that could serve the needs of the community, preserve the history and architecture of the building, and prevent a large amount of construction waste ending up in the landfill.

I support designation for the Channel 7 tower building. Others have described / discussed the building, its character and role far more eloquently that I might – so I'll not repeat those comments.

The building does reflect iconic – "brutal" architecture... how appropriate for a discussion like this...

I am encouraged that the Landmark Commission voted to recommend designation and the planning staff supports the designation.
