# WHATIT DOES?

### A BILL

For an ordinance creating a new article IX establishing access to free legal services to covered individuals in Denver facing covered eviction proceedings.

#### BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

@candicdebacaD9

Section 1. That a new article IX, Tenant Legal Services, be added to read as follows: Sec. -27-191. Legislative Intent.

The intent of this article is to establish a mechanism to provide free legal services and representation for low to moderate income individuals experiencing eviction; requiring the creation of an annual report that analyzes implementation and performance metrics in order to assess the continued needs of Denver residents and recommend adjustments to the criteria, policies, and procedures for the provision of legal services; and, requiring landlords to disclose to their tenants certain information regarding the right to full legal representation in eviction proceedings.










# WHAT IT DOES?

## COST

## \$3.8 million in legal services provision + \$200,000 for HOST FTE + outreach = \$4 million annual initial investment

- Denver Evictions filings (5-year average 2015-2019): 8,800
- RTC need and acceptance at 80% AMI: ~4,750
- Pilot program cost per case (generous!): \$880
  - Includes salaries and benefits for attorneys, paralegals, and navigators in additions to overhead costs
- Target cost per case: \$800
- HOST FTE (salary + benefits), marketing and outreach costs: \$200,000

# CONCERNS



Britta: Is HOST the right agency to do this?

Yes, eviction defense is a key component of housing stability and eviction defense dollars are going to HOST currently



Kniech: Is implementation date appropriate?

We can compromise based on Kniech's proposal of Sept. 1



Kniech: Can we cross-reference the registry code?

Yes, change made in new draft



Kniech: Does the DHA reference conflict with fed law?

No



Kniech: Does the definitions section on "covered individual" obligate us to serve anyone?



Torres: Do our legal partners have the capacity to provide services at this scale?

Yes, attorneys want to do this work and have been with little to meaningful investment



Torres: What is necessary to be a provider?

We currently put out an RFP with language specifying what we need. Qualifications are defined in RFP stage.
