



- Time and efficiency savings.


### **Challenges**

- Sound quality.






### Overall, do you feel Denver's move to online meetings has increased community participation?








### How are Denver Residents accessing meetings?








### **Do Denver Residents Want Meetings in Person or Remote?**








### **Do Denver Residents want a Council hybrid option?**










#### **Should Councilmembers Be Allowed to Attend Meetings Remotely?**

Do you think members of City Council should be given the flexibility to attend meetings remotely when there is not a declared emergency?








### Should Boards & Commissions Members Be Allowed to Attend Meetings Remotely?

- Any Board or Commission created in the Denver Revised Municipal Code that explicitly provides it is subject to local open meetings provisions; including Denver Food Commission (Healthy Food for Denver's Kids) and Caring for Denver Board.



## When Will The Law Apply? General Policy

#### Sec. 2-33. - Open meetings required; exceptions.

(d) Meetings shall be conducted in person at a designated physical location except in the following circumstances:

(1) The president of city council or the chair of any board or commission has the discretion to conduct a meeting including any hearings by electronic means in an emergency under 2-32 of this code. Meetings conducted by electronic means must provide the members of the public and city staff access to deliberations of the public body and meaningful opportunity to participate electronically in hearings of the public body.

(2) A member may request to participate in a meeting including any public hearings by electronic means if otherwise authorized by this code, rules or bylaws duly adopted by a public body.



# When Will The Law Apply? Definition of Emergency

### **Two Kinds of Emergencies: General & Personal**

- General:
  - *Emergency*. An emergency means any state of local disaster or emergency declared by the mayor, a public health order issued by the executive director of the department of public health and environment or other unforeseen circumstances that clearly threatens public health, safety, welfare or life.
- Personal:
  - A member of a public body may request to participate in a meeting including any public hearings by electronic means if otherwise authorized by this code, rules or bylaws duly adopted by a public body.
  - A member of city council may participate in a meeting including any public hearings by electronic means during work travel, personal or medical emergency, or if authorized by the President of council.



# When will the law apply? Electronic Presence & Quorum

#### Sec. 13-2. -Council rules governing meetings and procedures.

(c) A member of city council may participate in a meeting including any public hearings by electronic means during work travel, personal or medical emergency, or if authorized by the President of council. To establish presence for purposes of the charter § 3.1.6 and to establish a quorum under charter § 3.3.4, a member participating by electronic means must:

(1) Appear live on camera when establishing quorum, when speaking, and when voting;

(2) Appear using electronic means that includes video capability; and,

(3) Appear on video when casting a vote or such vote will not be recorded.

(a) Only hearings which are "essential/critical to maintaining citizen's physical and economic health" are currently proceeding.

(b) Individual councilmembers may listen to quasi-judicial hearings remotely but may not vote or participate in any other way.

(c) Hearings are only proceeding with an applicant's written consent and signed waiver.



## When will the law apply? Executive Sessions

#### Sec. 2-34. - Executive sessions.

(e) Notwithstanding section 2-33 of this code, attendance at executive sessions must be in person at a designated location and no member or participant is authorized to attend by electronic means.



## **Notice Requirements**

#### Sec. 2-35. - Public notice; exception for emergencies.

(a) Except as provided in the Charter and in sections 2-33 and 2-34, any meeting of or between a public body of the city, at which a quorum of the public body is expected to attend, shall be held only after notice thereof is given to the public not less than forty-eight (48) hours in advance of such meeting; and

- (1) Public notice shall be satisfied by:
- a. Electronic posting on the public website of the city and county of Denver or website of the applicable local public body; or,
- b. Posting by the means available whether in electronic or physical format at the principal office of such public body, or if no such office exists, at the building in which the meeting is to be held

(b) Notwithstanding any of the provisions of this article, an emergency meeting may be held without advance notice to the public when the person chairing the public body that is involved determines that an emergency situation exists; and the person may determine that such meeting shall be either open to the public or an executive session, as circumstances may require, without taking a vote as otherwise required by section 2-34(a); provided that the nature of the emergency and the action taken at such meeting shall be made known to the public within forty-eight (48) hours thereafter, in accordance with the provisions for posting of public notices of subsection (a).
