NOFA Contracts Overview

Scope of Work

Colorado Coalition for the Homeless (CCH) will provide ESG-CV, Emergency Shelter, Operations and Essential Services, providing integrated health services to people experiencing homelessness. These services are necessary to respond to and prevent the spread of COVID-19.

Background

Integrated health services will be located within the new emergency shelter located at 4600 E 48th Ave. Essential Services include: Outpatient Health, Mental Health, Substance Abuse Treatment, & case management. This contract will serve 1,300 unduplicated individuals.

Scope of Work

The Denver Rescue Mission will provide emergency shelter, operations and essential Services to people experiencing homelessness. These services are necessary to respond to and prevent the spread of COVID-19.

Background

This new contract will provide services at the new emergency shelter located at 4600 48th Ave & day Shelter at 2222 Lawrence Street. Services include case management and housing navigation. This contract will serve 14,300 individuals.



The Salvation Army – Rapid Re-housing Services #21-0567

Scope of Work

The Salvation Army will provide a range of short to medium-term, limited services through brief, solutionfocused case management to remove barriers to housing. All case management and housing navigation services are housing focused in their delivery.

Background

This contract is an expansion of The Salvation Army's Housing Now program that was supported through a previous contract. Rapid Re-housing provides temporary rent assistance coupled with housing navigation and case management. This contract will serve 100 unduplicated individuals annually for a total of 300 during the three-year contract term.
