This office has investigated the request from Kimley-Horn and Associates, Inc. c/o Eric McDaniel, dated January 19, 2021 on behalf of Greenbox IV LLC c/o Ryan Simpson for the relinquishment of the subject easement(s).

Project Title: 2021-RELINQ-0000005 4700 East Evans Avenue

Property Owner: Greenbox IV, LLC c/o Ryan Simpson

Description of Proposed Project: Proposing to relinquish the City and County of Denver Permanent Non-Exclusive Easement (PNEE), in its entirety, located at 4700 East Evans Avenue.

Background: The intent of the easement was to support wastewater facilities on this site. The proposed facilities were never constructed, and associated project canceled. The owner is requesting that the easement be relinquished to remove the exception from their title because it is no longer needed.
