To Whom It May Concern,

Thank you for accepting this easement relinquishment request for the above-noted Project. We are working with Trammell Crow Residential on exciting development located at the southwest corner of E. Evans Avenue and S. Broadway in the Overland Neighborhood. The Project is planned to provide retail, leasing, amenity spaces, and live/work units at the ground floor, an above grade parking garage, and four levels of market-rate residential apartments above. All existing structures on the site will be demolished as a part of the Project.

The Project provides a community designed to support an urban lifestyle. Renters will enjoy a range of amenities including a fitness facility, private outdoor courtyard space and retail services within their direct building. The market-rate apartments provide a mixture of unit types. Approximately 390 parking spaces will be provided for the renters and their guests in structured parking above grade. While our final site plan is still to be determined, the Project will be accessed from S. Acoma Street from the west. No vehicular access is planned from S. Broadway, E. Evans Avenue, and W. Warren Avenue.

On behalf of Trammell Crow Residential, the developer, and the property owner, Jon and Eric Helmstaedter, we would like to formally request an easement relinquishment for the reserved easement that remains following the vacation of the alley within the property as highlighted in the attached Site Plan, identified more specifically as Ordinance 370 Series 1991 (Rec. No. R-91-0060774).

With the relinquishment of the reserved easement associated with Ordinance 370 Series 1991 (Rec. No. R-91-0060774), any existing utilities including sanitary sewer and overhead electric that extend to the north within the existing easement will be removed. The proposed sanitary sewer modifications are depicted on the attached Utility Plan Exhibit showing a reroute of the sanitary sewer infrastructure around the Project perimeter in W. Warren Avenue, S. Acoma Street, and E. Evans Avenue. Additionally, the overhead dry utilities noted on the survey will be removed with the demolition of the existing structures and rerouted around the project in the abutting right-of-way. With the aforementioned relocations, there would be no need for easements to extend through the subject property for the purpose of conveying public utilities. Vacating this easement will allow the owner to redevelop and improve the area as planned. It is understood that any utilities that would require relocation will be done at the Owner's expense.


