23	WHEREAS, per Section 20-52 of the D	RMC, custodial funds do not require appropriation;

27	WHEREAS, the Department of Finance	e wishes to establish a new Special Revenue Fund to

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. A new fund is hereby established in the General Government Special Revenue Fund Series, the "American Rescue Plan Act" Fund, Accounting No. 11011, for the purpose of accounting for the receipt and expenditure of Coronavirus Local Fiscal Recovery Fund grant program dollars.

Section 2. Program expenditures are hereby authorized for the "American Rescue Plan Act" Fund, Accounting No. 11011, in the amount not to exceed the total of deposits described in Section 1 of this ordinance. Allowable expenditures include services and supplies, personnel services, capital equipment, transfers to capital project funds, or other program costs that the Department of Treasury deems allowable under the American Rescue Plan Act of 2021. All spending shall be authorized by City Council through approved allocations in the "American Rescue Plan Act" Fund. The expending authorities in the Fund are the agencies or departments administering the approved program dollars. This Fund is sponsor-based and non-lapsing.

Section 3. The proposed Grant Agreement, under CFDA 21.019, between the City and County of Denver and the United States Department of Treasury for the "Coronavirus Local Fiscal Recovery Fund" program, which is identified as OMB Number 1505-0271, a copy of which is duly filed with the City Clerk, Filing No. 202158783, be and hereby is approved in all respects.

Section 4. The payments made by the United States Department of Treasury to the City pursuant to and under the Grant Agreement shall be deposited into the Treasury of the City and credited to Special Revenue Fund No. 11000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

Section 5. That it be and is hereby found and determined that the budget summary of said program is as follows:
