A BILL

For an ordinance making rescissions from and appropriations in the General Fund.

WHEREAS, the 2021 General Fund budget includes an investment of \$1,395,000 in the Denver Department of Public Health and Environment for the Support Team Assisted Response (STAR) Program; and

WHEREAS, the administration and City Council wish to add \$1 million to the STAR program appropriation to expand coverage; and

WHEREAS, the Denver Police Department is partnering with community members to positively influence neighborhoods with high criminal activity by identifying neighborhood needs that if addressed can positively impact public safety, such as poor lighting, vacant property, poor trash collection, or fire risks; and

WHEREAS, Human Rights and Community Partnerships will require a supplemental appropriation of \$300,000 to provide compensation to community members who are volunteering to support this effort;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. From appropriations heretofore made from the General Fund listed or indicated in the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded" and transferred to the General Fund:

 4 rescissions, there is hereby appropriated to the appropriation accounts hereinafter designated the
 5 amount of money following such designation, to be expended for the purposes and upon the
 6 authorizations in said Ordinance set forth:
