6 **For an ordinance making rescissions from and appropriations in the General**
7 **Fund.**

9 **WHEREAS**, the 2021 General Fund budget includes an investment of \$1,395,000 in the
10 Denver Department of Public Health and Environment for the Support Team Assisted Response
11 (STAR) Program; and

12 **WHEREAS**, the administration and City Council wish to add \$1 million to the STAR program
13 appropriation to expand coverage; and

14 **WHEREAS**, the Denver Police Department is partnering with community members to
15 positively influence neighborhoods with high criminal activity by identifying neighborhood needs
16 that if addressed can positively impact public safety, such as poor lighting, vacant property, poor
17 trash collection, or fire risks; and

18 **WHEREAS**, Human Rights and Community Partnerships will require a supplemental
19 appropriation of \$300,000 to provide compensation to community members who are volunteering
20 to support this effort;

23 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**
24 **OF DENVER:**

26 **Section 1.** From appropriations heretofore made from the General Fund listed or indicated in
27 the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation
28 under the heading "Amount Rescinded" and transferred to the General Fund:
